OMC 6-1B-16: SILLY STRING AND STINK BOMBS PROHIBITED:

B.Prohibited Use, Possession Or Sale: No person shall use, possess, offer for sale or sell products commonly known as silly string or stink bombs within the city.

C.Exemption: This section shall not apply to prohibited products in transit or storage in interstate commerce.

D.Enforcement: The chief of police or his designee shall be responsible for the enforcement of this section. He is authorized to take any and all actions reasonably necessary for its enforcement including, but not limited to, inspection of any vendors or sale premises to verify compliance.

E.Nuisance Declared: The sale, possession or use of prohibited products is hereby declared to be a nuisance and may be enjoined by suit filed in Pierce County Superior Court.

F.Penalty: A person in violation of this section shall be guilty of a civil infraction and may be fined one hundred dollars (\$100.00). (Ord. 712, 8-27-1998)







D. Enforcement: The chief of police or his designee shall be this section. He is authorized to take any and all actions reenforcement including, but not limited to, inspection of any compliance.











