#### **Our Story So Far...**

There once was a small city of about 26,360 people *[OFM 2022]* Estimate, 4/1/22, subject to adjustments to reflect 7/18/22 US *Census CQR revision* that stretched from the south shore of Capital Lake *Subject to outcome of the Capitol Lake – Deschutes* Estuary Process, Estuary Alternative likely preferred alternative, Draft EIS 6/30/21 in the north, the Deschutes River [SMA] Shoreline of the State, SMP Update adopted 12/3/19 in the east, almost to Black Lake *Subject to the Tumwater-Thurston County* Joint Plan, update adopted 11/30/21 in the west, and Bush Prairie (Primarily under Port of Olympia ownership, subject to FAA deed restrictions on residential uses to the south...



#### **Our Story Continues...**

...this small city was similar to others of its size, but was unique in a special way, as **gophers**, **trees**, and **affordable housing** all wanted to call Tumwater home and the City supported their goals...





And that was problematic.



#### The Dilemma

- Gophers did not live in trees and did not like the development of affordable housing [They were also asocial animals, meaning they didn't even like other gophers, but that is another story...]
- Trees and gophers did not mix and people did not want to cut down trees for affordable housing
- Affordable housing was more difficult and expensive to build when protecting gophers and trees



#### **The Solution**

#### **Gophers living in affordable tree houses!**

Okay, that wasn't the real solution. This is what actually happened...




## Character #1 – Gophers:

The Olympia subspecies of the Mazama gopher calls the southern two thirds of Tumwater and a similarly sized area to the south in

the County home...



- This native prairie was easy to develop
- Then the federal government listed the gopher as threatened under the ESA





#### Habitat Conservation Plan

- Tumwater and the Port of Olympia started working with USFWS on a Habitat Conservation Plan (HCP) in 2016
- > The HCP covers the **gopher** and three other species in the



#### > The HCP will:

- Allow for higher quality and more efficient long-term species protection
- Reduce uncertainty, costs, and delays for new development and redevelopment envisioned by the City and Port

CITY OF TUMWATTER

• Allow continued and ongoing maintenance of City and Port facilities

#### **Habitat Conservation Plan - Status**

- > Still working on an HCP with USFWS
- Final public draft should be issued soon and then environmental review will start

**Expected Result**: Better long term future for **gopher** survival in support of the federal **gopher** recovery plan and more urban land available for **affordable housing**

### **Tree Plans and Actions**

- Urban Forestry Management Plan (UFMP) (2021)
- Thurston Climate Action Plan (TCMP) (2021)
- Actions to support the goals of the UFMP and TCMP:
  - "The Right **Tree** in the Right Place"
  - Urban canopy coverage goals in the City
  - Protecting **trees** and forests in the rural areas
- > Updates to the following:
  - **Tree** and vegetation retention regulations (2022-23)
  - Street **Tree** Plan (2021-23)
- Landscaping regulations (2022-23)







#### **Tree Related Actions**

**Expected Result**: A healthy urban forest and **trees** grown within the City providing many environmental, economic, and community benefits

UFMP explicitly balances the protection of the urban forest with other City strategic priorities, which include **affordable housing**, developing a walkable, urban community, economic development, and protecting endangered species, such as the **gopher** 



## Character #3 – Affordable Housing:

- In 2018, the Mayor and the City Council directed staff to undertake a number of actions to address **affordable housing** and homelessness:
- > Affordable Housing
  - "Don't call it 'missing middle" code changes
  - Fee reductions
  - Mobile home park and tenant protections

#### > Homelessness

- Working with the Tumwater School District and non-profits to house homeless students and families
- Committing resources through the Regional Housing Council



#### **Housing Action Plan**

- ➤ Tumwater Housing Action Plan (Actions 2021 )
  - Began as a collaborative effort between the Cities of Lacey, Olympia, and Tumwater
  - The City Council adopted the City's Housing Action Plan in 2021 to reflect the specific conditions and concerns of the City
- ➤ Comprehensive Plan Housing Element Update (2022 25)

#### **Affordable Housing Related Actions**

**Expected Result**: Work will inform further updates to the City's Comprehensive Plan policies and development regulations and guide implementation strategies to help the City meet its **affordable housing** needs and strategic objectives
